Local Slivers.

-A thaw is threatening.

-St. Valentine's Day next Thursday. -The upper mill dock wears a lively and animated appearance.

-The Green Bay mail now arrives before dark nearly every evening.

-Don't forget to read the new advertisements in this week's issue.

-Circuit Court convenes at this place a week from next Tuesday, the 19th.

---Sheriff Houle is busy summoning the jury for the approaching term of the Circuit Court.

-A gang of men and teams are engaged in extending Mr. Harris' dock into deep water, on the west shore of the bay.

-The old tin shop on Spruce-street, used as a saloon by Joe Stroh, has been raised about two feet and is to be moved back several feet.

-A heavy gale from the southwest prevailed here Tuesday night. It must have used up the ice on Green Bay pretty effectually.

-It makes a fellow's mouth water to see the number of county correspondents with which the Kewaunee *Enterprise* is favored weekly.

-Green Bay has finally succumbed to the cold weather, and gone into winter quarters. The cold snap of Sunday night, the 27th ult., did the business.

-Our readers will find a readable letter on the second page of this issue. It is written by one of Door county's former favorite citizens, Mr. S. C. Senn.

-Mr. Harris informs us that real estate business is lively over at Bay View. On Monday he disposed of three lots, and the demand is for more and more. the inevitable result.

-There is a general impression that our village school girls carry their books home at night in order to study the lessons of the following day, but a reporter on this paper affirms that they do so for the purpose of sliding down hill on the atlases and slates.

-Business is unusually quiet at Fish Creek this winter, owing in a great measure to the absence of snow and ice. Winter fishing, which has been car 1878 Feb 07 point

-The smoothness of the ice, and the absence of any considerable quantity of snow on our bay above the upper mill, affords an unexcelled opportunity for a horse trot. Why don't the owners of some of our fast "stock" get up some little excitement in this line?

-In the intervals of other labor, Mr. Alex. Laurie is preparing material for a yacht thirty feet long, to be constructed at his leisure. It will be sloop-rigged, and the model gives promise of a craft that will show its heels to anything of its class in Green Bay waters.

-About 12 o'clock Saturday night last, Mr. W. F. Post discovered an ash barrel blazing in the rear of Lawrence & Co.'s store. Fortunately he was able to extinguish the fire before it communicated to the neighboring buildings, and thus a great calamity was happily averted.

WORK on Mr. Harris' pier is progressing satisfactorily. The cribs built this year have been filled with stone, and the stringers are now being put on. This done the planks will be laid. There are only about eight feet of water at the outer end of the wharf at present; but the owner intends adding an oblong structure 60x100 feet, which will give all the wharfage required to accommodate the present business. 
THE repairs on the forry scow Ark are progressing as fast as can be expected when the amount and extent of the work is taken into account. The company's property in Sawyer consists of a large elevator, dock property and large warehouses. The elevator has a capacity of 30,000 bushels of grain and 'is equipped with the latest machinery, which is run by an eight horse power Fairbanks-Morse gasoline engine. The elevator is power Fairbanks-Morse gasoline engine. equipped with a clipper cleaner and automatic scales, which are of great value in a business of this kind. The elevator stands go feet high, and is located where shipments can be made from it by either rail or boat. The firm makes a speci-alty of handling peas and thousands of bushels are shipped south each year, they being put up in bags and transported to the southern market by boat. The majority of the wheat, rye and barley handled by the firm is shipped south in bulk by rail, the cars being run to the elevator on a side track, where they are quickly loaded. Five men are generally kept employed about the elevator, and the handling of the grain is in charge of Jeff Teweles, an experienced man in that line of business. miter p



Books giving a personal account of some part of our military cam-paigns are also in great demand, such as Ernie Pyle's, "Here is Your War.". The circulation from this class was 1433, practically double that of last year. Reading of travel books also increased, for as our local boys reach the far corners of the globe, their parents and friends are eager to learn more about those places."



Sturgeon Bay's worst fire since the Prange-Washburn store bura-ed some years ngo swept through the large Brandels dock and warehouse on the Sawyer waterfront Wednesday.hight and only valiant work on the part of Chief George Jensen's firemen and a contingent of constguardmen from the cap-tain of the port barracks made it possible to save the adjoining grain elevator. Stanley Brandels, who owns the

Stanley Brandeis, who owns the business and contents, leasing the buildings from his mother, Mrs. T. Brandeis, said he was unable to give an estimate of the loss but that inaurance adjusters were due Friday. Insurance carried on the buildings, however, was far from enough to rebuild it, he said.

Got a Big Start

With its full 500-gallon-per-min-ute capacity all forced into one stream, the costguardmen wero shife to throw a stream clear ap onto the elevator roof, extinguish-ing small flames that broke out the atter time. One fire depari-ment stream was played on the flaming warehouse, while another was used on the south. Later in the night, the big pump-

Later in the night, the big pump-er was substituted at the hydrant and the three-th-one deluge 'noz-sle was set up to spray the whole south side of the elevator and fur-ther diminish the intense heat. Even then, fire continued to flara up between the iron sheeting and wood siding, requiring the fire-ment to remain constantly on the altert unit 10 an. Thursday. Small portable pumpers from the Canal post guard station were called about midnight to help keep down the flames on the dock.



Record Budget Adopted by City Council

The Sturgeon Bay city council Tuesday night adopted a budget calling for a tax rate of \$48 per thousand dollars of assessed valuation. The new tax rate is \$1.50 less than the present rate but will result in more taxes being collected.

The assessment levels were raised approximately 20 per centduring the past year, making it possible for citizens to pay higher taxes under a reduced .tax rate.

The budget, plus state and county levies, will bring the total amount of taxes to be levied in Sturgeon Bay to \$708, 384, an increase of approximately \$95,-000 over the last levy.

Adoption of the budget came after a delegation from the Stur-geon Bay board of education appeared - to protest the action taken by the city council in slashing the proposed school tax levy by \$23,500. The board asked that the money be restored to the school levy request.

The appeal was to no avail, however, so it appears that the board of education will have to either operate on the money to be made available or go to the council for a deficit appropria-tion when the tax money for school purposes has been spent. The tax levy for the 1958

budget is the highest in the history of the city.




